During the performance of this contract, the contractor agrees as follows:

2. CONTRACT WORK HOURS AND SAFETY STANDARDS ACT

Compliance with the Contract Work Hours and Safety Standards Act.

- A. Overtime requirements. D. **Subcontracts**.
